**AND NUMBER OF HOMES**



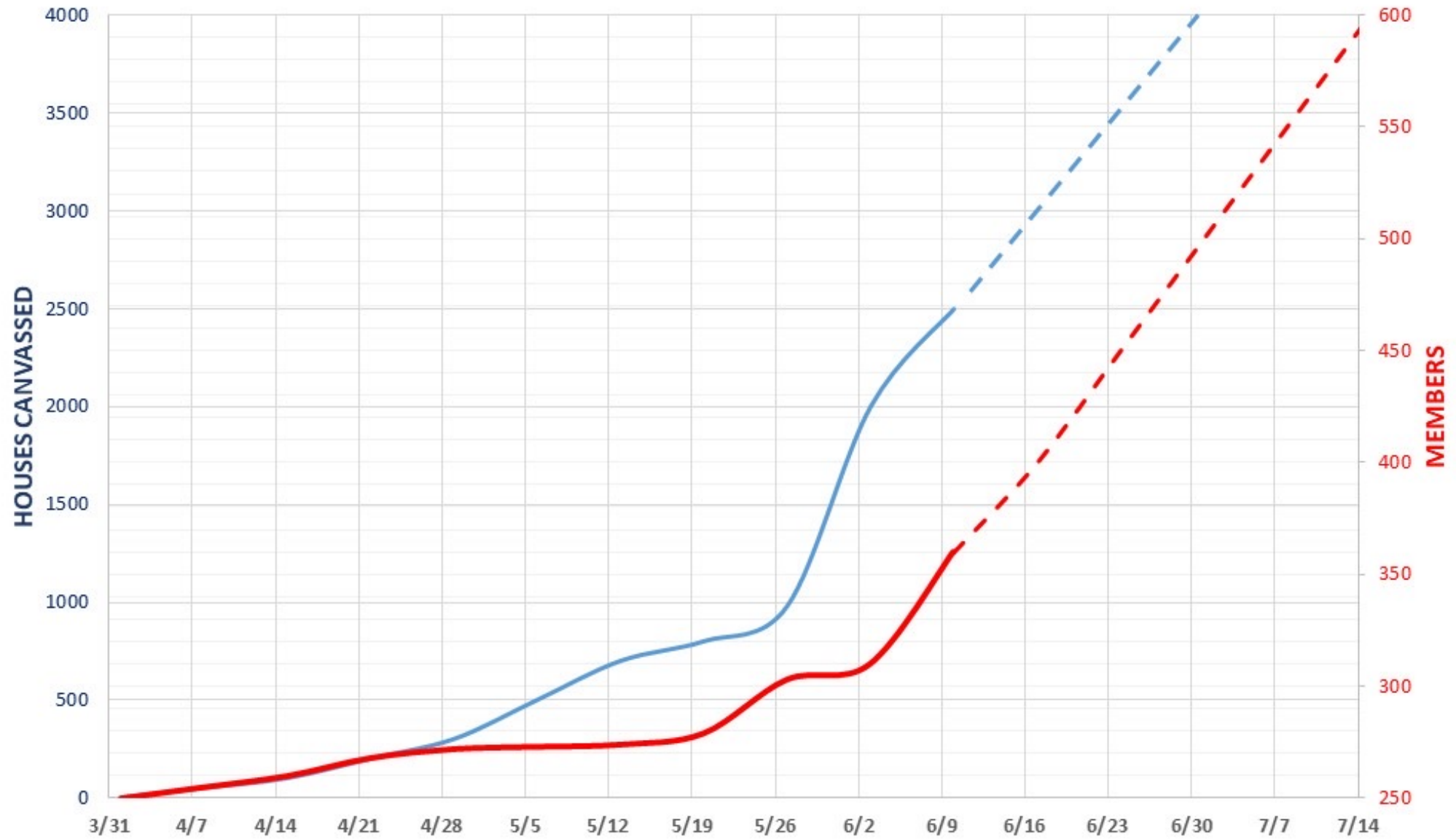
